A Note from the MTF President

Dear MTF Members and Supporters,

As we begin a new year and look towards a new Legislative Session, I am pleased to share the Massachusetts Taxpayers Foundation's 2024 Annual Report. This brief report does not capture all that we accomplished over the last year, but we hope it demonstrates MTF's fundamental role in the Commonwealth. We strive to produce high-quality and unbiased research that engages our members and policymakers, and that drives a more equitable and sustainable economy for all Massachusetts residents.

In 2024, MTF published 54 reports that examined issues across the policy spectrum, including the first annual Massachusetts Competitiveness Index. Our reports, analyses, and expertise were cited in the media nearly 800 times, and our work shaped the narrative around some of the most pressing policy issues facing the state. To promote our research and connect stakeholders with key policy leaders, MTF held 27 events over the course of the year.

Ultimately, the impact of our research and events is measured through the strength, engagement, and diversity of MTF's membership and partners, and 2024 was a banner year in that regard. MTF added 30 new members over the last 12 months, reaching new highs for both member and grant support. At the same time, we launched a new Trustee Sponsored Membership program to encourage diverse voices to join MTF and get a sense of what we have to offer. The growth in MTF's publications, events, and impact is a function of the energy and perspective of all those who support us.

We hope you find this Annual report informative and interesting. We also hope that it demonstrates how critical your ongoing support of and engagement with MTF is to our work and success. Thank you for making 2024 such a successful year for MTF, and here's to an even more successful 2025!

Research

In 2024, MTF published 54 reports ranging from in-time analysis of the state budget process and long-term research in several public policy areas, including demographics, education, healthcare, housing, transportation, and workforce development.



Massachusetts Competitiveness Index

This year, MTF also released its first annual Massachusetts Competitiveness Index with support from the Massachusetts Competitiveness Partnership and in partnership with the UMass Donohue Institute. The report uses 26 metrics to rank Massachusetts against itself, its economic and geographic competitors, and nationally to measure the state's ability to attract and retain talent and businesses.

Media Impact

In 2024, **MTF's reports, analysis, and expertise were featured nearly 800 times in the media**, including online media and local TV coverage. Our work has helped shape important policy decisions this year in areas like federal funding, early education and care, transportation, and commercial real estate.



The Fellowship provides educational and professional benefits by providing real-world exposure to policymaking, professional experience as a policy researcher, and mentoring and networking to get the Fellow started on a career in policy.

MTF's inaugural Fellow, Leedya Senbetta, joined MTF in 2023 after graduating from Boston University's School of Public Health, where he earned a Master of Public Health in Policy and Law. Leedya authored several MTF reports, including MassHealth enrollment trends and the end of continuous coverage and a chartbook on the pediatric behavioral health crisis. Leedya also had the opportunity to network with over 40 members and key stakeholders and participated in nine shadow days with partner organizations. She concluded her Fellowship in November 2024.

Alexandria Sheehan joined MTF in September 2024 after graduating from Worcester Polytechnic Institute with a Bachelor of Science in Economic Science, where she conducted undergraduate research in housing and environmental policy. In addition to general state budget analysis, Alexandria's work at MTF will focus on housing and healthcare policy.
