Dear MTF Members and Supporters,



Research

In 2025, MTF published 58 reports ranging from in-time analysis of the state budget process and long-term research in several public policy areas, including demographics, education, healthcare, housing, transportation, and workforce development.

This year, MTF also released its second annual Massachusetts Competitiveness Index in addition to a companion poll commissioned by the MassINC Polling Group on how Bay State residents view the state's ability to attract and retain talent and businesses. The report uses 26 metrics to rank Massachusetts against itself, its economic and geographic competitors, and nationally to measure the state's ability to attract and retain talent and businesses.

Governor Healey's Fiscal Year 2026 Budget

Today, the Healey-Driscoll administration released its Fiscal Year (FY) 2026 budget proposal. The \$62 billion spending plan increases spending over the FY 2025 GAA by \$4.3 billion (7.4 percent) and over the administration's estimated spending level of \$60.256 billion by \$1.8 billion (2.1 percent). Spending increases are reflected in the healthcare, education, and transportation sectors driven by non-discretionary cost

The pandemic hugely disrupted the state's economy and workforce, as unemployment rates jumped from 3.1 percent in February 2020, one of the lowest in state history, to 17.8 percent in April 2020, the highest in over four decades. During the pandemic, state and federal unemployment benefits were expanded to address the unprecedented spike in unemployment, and billions in federal loans were used to keep the Unemployment Insurance (UI) program solvent. Expert: Economic downturn could trump impacts of GOP changes

Testifying before the House Committee on Federal Funding, Policy and Accountability, **Doug Howgate, president of the Massachusetts Taxpayers Foundation**, laid out the scale of the state's dependence on federal money: about \$25 billion each year. That includes about \$14.4 billion in Medicaid funds, as well as transportation and water infrastructure funding, and billions more in federal grants administered through state agencies.

Fellowship

Policy Start Fellowship

MTF, in partnership with the Association of Independent Colleges and Universities of Massachusetts (AICUM) and its member schools, offers a 14-month Policy Start Fellowship (PSF) for graduates from communities that have been historically underrepresented in state policy research. The Fellowship provides educational and professional benefits by providing real-world exposure to policymaking, professional experience as a policy researcher, and mentoring and networking to get the Fellow started on a career in policy.

2024 Fellow

Alexandria Sheehan joined MTF in September 2024 after graduating from Worcester Polytechnic Institute with a Bachelor of Science in Economic Science, where she conducted undergraduate research in housing and environmental policy. During her Fellowship, Alex authored two reports on the state's emergency housing assistance system and a summary of the Governor's environmental bond bill, and supported the organization's analysis on the state budget. Alex completed nine shadow days and networked with over 40 MTF members and partners. Once the Fellowship concluded, Alex joined the Senate Committee on Ways and Means as a Fiscal Analyst.



2025 Fellow

April Beatty joined MTF in September 2025 after graduating from Simmons University with a Bachelor of Arts in Economics and Political Science and a Master's in Public Policy. During her time as a student, April completed several internships in the public sector, including the U.S. Senate, U.S. House of Representatives, and at the Massachusetts House of Representatives. April will contribute to the organization's state budget research while pursuing research projects in other policy areas. Her Fellowship will conclude in November 2026.

Mid-Career Fellowship

This year, MTF launched the Mid-Career Fellowship to provide a professional with experience in the public sector with an opportunity to conduct research and publish written material on public policy issues of interest, present work to a broad audience, and dedicate time to networking and career development. The 12-month Fellowship is intended to enhance MTF's research capabilities, while also providing the Fellow with a unique opportunity to pursue the next stage of their career and undertake interesting and relevant policy work.
